The proposal is hereby incorporated into the lease by reference.</p> <p>The Change Order #4 in the amount of \$3,018.67 is to be paid via a one-time lump sum payment. All lump sum payments shall be paid upon inspection and acceptance by the Government of the said alterations.</p> <p>The lessor hereby waives restoration as a result of all improvements.</p> <p>All other terms and conditions of the lease shall remain in force and effect.</p> <p>IN WITNESS WHEREOF, the parties subscribed their names as of the above date.</p>
