1. Paragraph 1 of the Lease is hereby amended to update the address of the leased premises. The address of the premises shall now be 1 Archives Drive, St. Louis, Missouri 63138. This address change formally updates the official United States Postal Service address of the premises.

**All other terms and conditions of the Lease shall remain in full force and effect.**


