WHEREAS, the parties hereto desire to amend the above Lease to establish the Tenant Improvement build-out costs associated with Change Orders 23 - 27.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective November 7, 2011 as follows:

A. The Government shall pay the Lessor a one-time lump payment in an amount of \$50,931.37 for Change Orders 23 - 27. The break-down of this payment is outlined in Exhibit A (attached)

B. Invoicing for lump-sum payment:

Upon completion of the work, the Lessor shall notify the contracting officer to arrange for an inspection.
